

# 2022-2023 STUDENT SCHOLARSHIPS


\$73,000 Available for Eligible Real Estate Students

- \$600 per semester, up to \$1200 per year
- Non-Competitive (First come, first served)
- Successfully completed at least 1 real estate class (3-unit)
- Currently enrolled in at least 1 real estate class (3-unit)
- Eligible for California College Promise Grant Program or demonstrate other financial need
- Students submit application to their college, college submits invoice to the Foundation for California Community College






### REAL ESTATE ENROLLMENT DATA Statewide Enrollment in California Community Colleges Real Estate Courses
